

CONTRAINDICATIONS

As with many forms of treatment and therapy, there are certain circumstances during which certain modalities of the HOCATT™ should not be used. The following modalities are contraindicated for:

STEAM/FIR SAUNA

- Fever
- Taking blood thinners (e.g. warfarin)
- Hemophiliacs (prone to bleeding)
- Active bleeding
- Menstruation
- Drunk/Hungover
- Recent heart attack-consult your doctor
- Early 3 months of pregnancy
- Young children (<12 years)

OZONE THERAPY

- Thyrotoxicosis
- G6PD deficiency (Favism)
- Early 3 months of pregnancy

CARBONIC ACID THERAPY

- Hypotension (the user may faint)

ELECTROTHERAPY & ULTRASONIC CAVITATION

Do no use in/over/on:

- Head and neck area
- The acute stage of an injury (where the user may still be bleeding)
- Metal pins, plates, etc.
- Cancerous tissue
- Infected tissue
- Sensitive areas (such as the testicles)
- The chest of a user with a pacemaker
- The back or abdomen of a pregnant woman
